The Companies (Fees) Order, 1997.

AN ORDER made by the Minister under sections 201 and 219 of the Companies Act, 1996 - 22.

1. Citation and commencement

- (1) This Order may be cited as the Companies (Fees) Order, 1997.
- (2) This Order shall come into force on 3rd of April, 1997.

2. Fees to be paid to the Registrar

- (1) The fees set out in the second column of the Schedule hereto shall be the fees payable in respect of the transactions set out in the first column of that Schedule.
- (2) The fee payable to the Registrar under section 135 of the Act for a copy of a report made by inspectors appointed under section 128 of the Act shall be at the rate of 1 dollar per page of the report.
